I. Call to Order -3:32 p.m.

II. Minutes

• Minutes were unanimously approved as submitted.

III. Curriculum

- FINA 601 New Course Proposal
 - o This course is custom built to meet the needs of MS GIS program targeted for non-business graduate students.
 - o Has been taught since 2017 under different number.
 - o Making it a new course.
 - o Recommended for approval by GCC. Seconded by Melissa Bugdal. Vote was unanimous.
- MKTG 560 and MKTG 685 Course Change
 - o Courses are no longer taught and need to be dropped from course listings.
 - o Recommended for approval by GCC. Seconded by H. Diehl. Vote was unanimous.
- HHPF 502, 512, 513, 514, 515, 522, 523, 532, 534, 542, 544, 545, 546, 553, 557, 558, 559, 562, 590, 692, 693 Course Change
 - o Updating prefix from AHPH to HHPF to align with new program name approved by MHEC.
 - o Will be reviewed at next level to decide if further approval is necessary.
 - No change to courses.
 - o defense requirement.

o Recommended for approval by GCC. Seconded by S. Weaver. Vote was unanimous.

Large group of new proposals were submitted too late for November meeting. If December meeting is cancelled, J. Scott will send out for electronic vote.

IV. GPD Institutes – Jessica Clark

- Noticed a missing piece to orientation events Grad Program Director Institute.
- Would be similar to a Chairs Institute but more specific and focused on Grad Program Director needs.
- Chairs Institutes are typically a ½ day event. Topics change each year and case studies are used that are applicable to situations facing chairs.
 - o C. Griffin As you work up agenda, would be helpful to include items related to training and resources.
 - o Examples: Best practices in marketing and advertising, fostering inclusivity, enrollment, graduate student success, training.
- C. Carayon will collect needs and ideas and submit a comprehensive list to J. Clark.
- J. Clark will then draft something and get it to everyone to review in the spring.

V. English Language Follow-up – C. Griffin

- This has been discussed several times over the years.
- Grad Council should review the current language and if there is any interesting in modifying the language, OGS can spearhead that.
- Would be helpful if graduate review had a broader perspective (like undergrad) and not be entirely based on standardized testing. Consider alternate methods of validating English proficiency. Have discussed some of these with Brian Stiegler.
- C. Carayon Questioned the effect on ELI's capacity
 - o C. Griffin Would provide more validity to ELI as current admission decisions do not factor in ELI results. We will include ELI folks in the conversation.
- D. Wagner Conversation occurred several years ago while starting exchange programs with Chinese institutions. Found that writing was better but oral comprehension skills had challenges. TESOL resources were not readily available.
 - A. Koehler CSA used to have an ELI tutor but funding went away. Trying to reestablish that position.
- C. Griffin If modifications are made, it would be to minimum university standards. Individual programs can have higher standards.

VI. Revisit Adjustments to Brand – C. Carayon

- At October meeting we discussed how new brand is not geared towards graduate education. J. Scott did get the caption corrected under Jessica Strange's picture, to identify her as a grad student.
- As is, the website cannot be used to market graduate programs.
- C. Griffin Images are more SU-centric now. Grad Council can put together a statement to give to the Provost about how graduate studies is not captured in the new brand. All suggestions for improvement are welcome.
 - C. Carayon Failed opportunity to highlight graduate research and the hands-on experience of the Nabb Center and internships.

- T. Williamson Promotional YouTube video includes no older students. We need to include students who look like the students we're trying to recruit. We need a more cohesive video, maybe a separate one, that shows professionals in their fields.
- J. Nieves The graduate presence is more than just a percentage. Should be including things like grad seminars, Writing Center, online and satellite students and TA's in the classroom.
- C. Griffin Grad Council can put forth a document stating these items. While we appreciate the changes to imagery on the website, there are still opportunities for growth and we need to capture what grad students are participating in on campus. Should go to Sue and Karen as an action item.

VII. Revisit Travel Expenses for Students

- SU has changed in terms of number of people conducting research but policies have not been updated.
- Difficult to help students find funding for conferences.
 - o T. Williamson Worked with J. Scott to compile opportunities for education students.
 - o C. Griffin Created the Research and Presentation (RAP) Grant when he arrived at SU. Will consider raising max funding from \$500 to \$750.
 - S. Hamilton It's not just about conferences. It's about paying for travel so students can conduct research. Sometimes credit cards have to be in person.
 - C. Griffin Our office will reach out to Accounts Payable to see what options are available.
 Clifton supports reducing the burden on students.

VIII. Subs and Waivers – D. Wagner

- Go to your Deans and ask that the Registrar have the resources and staff they need. They are the same as they were when we had half the current enrollment.
- Subs and waivers take forever and affect a student's audit. And if affect advising since students can't look at the progress reports since they aren't updated in a timely manner.
- SU established a large advising center which cannot help with any grad issues.
- Marty Registrar has had 365 requests since September 1st. Sometimes there are 50-60 per week.
 Working on a new program to make sub and waiver requests quicker. Will start training with Grad Program Directors as soon as it is up and running.
 - o C. Griffin Please include Jessica Scott. OGS is willing to help in any way if there is access.
 - o D. Price If Grad Faculty have more access, they can also help expedite things.

IX. GSC Update – J. Strange

- Been having regular meetings with Assembly.
- Been working with Andrew and SGA. He's allowing GSC to do a PowerPoint at one of their open forums on deadlines and research opportunities.
- Once the branding statement is completed, she would also like to bring this up during PAT meetings.
- GSC FINALLY has office space!! Will be housed in the current Career Services since they're moving.
- Met with Kevin Fallon and encouraged him to bring back CV and resume services. As a reminder, there is a closet on campus with professional outfits to be used for interviews, presenting, etc.
- Reached out to HALO to help with Trees of Hope.
- Starting conversations with campus NAACP on possible joint efforts.

- GSC members will be volunteering at Grad Walk.
- Thanks for always supporting the GSC
