July minutes were reviewed and approved

I. Reports

- a. Kevin Vedder
 - i. Original return to campus document will be updated with new information and released in the near future.
 - ii. Daily COVID19 screening using Android and Apple App called SU Mobile has been implemented and should be completed daily even if teleworking
 - iii. Testing for all SU members starts tomorrow. Will be conducting follow-on testing. More information will be released once the details have been worked out

b. President Wight

- i. The goal is for routine testing of the campus. USM might release protocol that requires a follow-up mid-semester comprehensive testing of the campus.
- ii. SU was able to test around 200 people in about an hour. We're conducting testing almost entirely with our own people means it's cost effective and we can test possible outbreak clusters quickly.
- iii. Acknowledged that everyone is working as hard as they can to start a semester that's going to look very different than usual thank you for the tremendous effort
- iv. Enrollment numbers are 6.5 7% down. Not where I want to be but we'll manage it.
- v. There is a healthy balance left over from the CARES Act that is available for the fall semester students haven't been making full use of that resource yet. Can't be used for tuition and fees, but it can cover transportation and technology cost for students.
- vi. A Senator ask about College Park and their plan to start the first two weeks online. Answer: It is not my intention to start the first two weeks online. College Park has a very different dynamic of bringing students to PG county which has higher COVID19 rates than Wicomico and a student body of 40,000+

- ii. The due date for changes to benefit elections changed from July 1st to July 29th
- iii. Regent staff awards announced 2 from SU, Meghan Baker & Claire Williams both were nonexempt nominations
- iv. Planning for upcoming year and housekeeping items
